To obtain this Permit all applicants must first be a full Adult Permit holder of Amalgamated Fisheries Limited. An Adult is deemed to be a person who has passed his/her sixteenth birthday and paid the full Adult Permit fee as decreed by the Company.

Night fishing period is defined as the hours between one hour before sunset until one hour after sunrise.

The holder of the Night Fishing Permit will fish only the waters herewith designated and must not fish any one stretch of water for more than twenty-four hours in any seventy-two period. The holder of the Permit must agree to accept and obey any special directives or rules, which may effect or apply either permanently or temporarily to any particular or individual water or fishery.

This Permit must be carried at all times when night fishing on the Companies water and produced for inspection to any Official Company Bailiff or other member who first produces his/her own membership card/permit as proof of identity.

The Permit of any person failing to obey these rules will be rescinded forthwith.

Rules of Night Fishing

1. Night Fishing is banned from 24 hours before a contest scheduled in the Match calendar is to be fished on any of the Companies water
2. Night Permit holders may erect a tent or bivouac while carp fishing but must remove it at the end of the allowed 24-hour session. Bivouacs or tents shall not be used when Barbel fishing
3. Fish may be kept in **Carp Sacks only** while night fishing for carp as long as it takes to identify and to take photographs only. Ordinary keepnets are banned. Barbel must never be kept in nets of any kind. Anyone who keeps a fish in a net for a “considered excessive period” will be deemed to have broken the rules and will be reported to the Company and suspended for a term at the Companies discretion (this rule does not apply to Bream or Roach fishing or other small fish species)
4. All the rules specified in the Companies permit apply to the night permit holders
5. It is strictly forbidden to light fires. Do not enter or encroach on any property other than that specified in the list of waters provided herewith
